

INSTALLATION INSTRUCTIONS

JUNO 27HYP AND 204HYP HYPERBOLIC TRIMS

SAVE THESE INSTRUCTIONS

TO INSTALL HYPERBOLIC TRIMS:

 Remove OPTIC REFLECTOR from fixture by rotating ¼ turn counter-clockwise (Figure 1). Discard or recycle.

Note: If replacing an existing trim with a hyperbolic trim, remove existing trim and OPTIC REFLECTOR from fixture.

2. Align the mounting tabs of HYPERBOLIC NMC™ (Nano Mixing Chamber) OPTIC to the optic mounts in fixture as shown in Figure 2a & 2b. Rotate ¼ turn clockwise until it stops as shown in Figure 2c.







TO INSTALL HYPERBOLIC TRIMS (CONTINUED):

- 3. Install reflector assembly springs into spring brackets in fixture (Figure 3).
- 4. Gently guide the hyperbolic reflector into fixture. HYPERBOLIC NMC™ OPTIC lens needs to fit into reflector opening (Figure 4).






