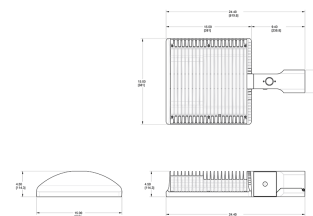


# RWLED2T150Y/D10
